

Trump rewriting global trade rules

The German foreign trade engine is still humming along, but the rules for global trade are being rewritten. The driver is the USA: whether it is the tightening of the Russia sanctions, punitive tariffs or the withdrawal from the nuclear deal with Iran – supposedly reliable trade agreements are becoming invalid overnight. In return, the EU is tightening the anti-boycott regulation, which is confronting companies with a dilemma: if they subject their business policies to US sanctions, they violate EU law. If they hold on to their Iran business, those with US business face severe penalties in the States.

But protectionist trends are not limited to the US. With the amendment of the Foreign Trade Regulation, the German federal government extended its control on foreign investments to protect key technologies and critical infrastructure from excessive influence by non-EU investors. This is making cross-border deals more difficult.

Customs are also applying stricter controls and interpreting current legislation more restrictively. The number of criminal proceedings in customs and trade is on the increase. In addition, technical developments such as the export of software for connectivity systems in the automotive sector pose new legal challenges for companies. More and more often, these are using pitches to find the right law firm.

Questions about sanctions and embargo law as well as compliance advice related to customs and

trade are also providing plenty of work. Once rather a niche topic, the importance of the practice is increasing in line with companies' need for advice. **Freshfields Bruckhaus Deringer**, which has focused chiefly on cross-border transactions since its customs and trade practice spun off as **Blomstein**, is broadening its advisory spectrum towards export controls. **Dentons** brought in a renowned counsel from **Baker & McKenzie** for reinforcement in this field. After the Iran offices of **CMS Hasche Sigle, Rödl & Partner** and **Wülfig Zeuner Rechel**, which opened with great expectations, demonstrated initial success in 2017, their future has been called into question with the US' withdrawal from the nuclear deal. But since many companies want to continue their business relations with Iran and the markets in the Gulf region as a whole continue to be of interest to them, the Iran offices may well provide a locational advantage in the future.

Focus on customs law thanks to US politics

Customs law is now front and center again owing to the US' punitive tariffs on steel and aluminum. Some firms, like **Oppenhoff**, traditionally advise on this issue via their tax practices, but smaller outfits, such as **Harnischmacher Löer Wensing** or solo lawyer **Helmut Bleier**, are also carving out a profile in the market. Once again, however, no other firm succeeds at covering the entire field of customs and trade with such breadth and depth as **GvW Graf von Westphalen**.
